The applicant needs to be able to work in a multi- cultural environment and is expected to have the vision to lead and contribute to AO CMF Research and to help us set new standards and position AO CMF as an academic leader in Craniomaxillofacial research.

## Responsibilities

Chair the AO CMF R&D Commission that has the following functions and duties:

- Define the AO CMF R&D focus and priorities based on identified relevant clinical problems
- Represent AO CMF R&D within the AO CMF International Board (ex officio voting member; 3-4 meetings per year)
- Coordinate all AO CMF R&D activities
- Advise the AO CMF International Board on matters related to research and development
- Support AO CMF R&D budget planning (within framework defined by AO CMF International Board)
- Submit AO CMF R&D budget to AO CMF International Board for approval
- Function as point of contact on R&D related issues for AO CMF community members
- Supervise and monitor AO CMF R&D projects (milestones and budget)
- Define Peer Review process (combined effort with other Specialties and entities)
- Coordination of the review of applications for new projects and extensions in accordance with the defined peer review process
- Delegated (presently delegated by the AO CMF International Board) responsibility for funding of all AO CMF research at an international level and for the monitoring of that research. This includes presently designated earmarked funding in AO Research institutions.
- Responsibility for any subcommittees (there is currently only one, a Clinical Priority Program committee for Imaging and Planning in Surgery)
- Comply to the AO F Shared values and the Code Of Ethics
- Does not hold other governance positions in AO CMF. If elected and keen to assume the position, he/she will be required to resign from the prior position as soon as the term as new chairperson begins

## Compensation

- The Chairperson of the AO CMF Research & Development Commission currently receives an annual stipend of CHF 20'000 as compensation for his / her efforts.
- The annual stipend compensates for all activities except reimbursement of travel / accommodation expenses and per diem for course faculty and course chairperson activities if such activities do not take place on the same day and same location of other AO activities
- The annual stipend amount is a gross amount, i.e. income and social tax will be deducted depending on the individual situation of the Chairperson (e.g. source tax 25% and social tax 6%). In addition, AO has to pay employer social security tax of approx. 9%.
