MENA Board Decisions

Please be aware of the following two Regional Board decisions that were passed recently:

Membership

50% membership fee discount for Residents/
Students (max 7 years from the beginning of Residency) including
Assistant Lecturers, provided this is confirmed in their letter of Residency. Once the seven years are over, Residents must modify their membership status.

Elections

Residents must be members for at least two consecutive years in order to vote in an election.

Meet a Member Wael Chaaban, UAE

Hi All.

It is a great pleasure to say "Hello" to you and share my experience over the last 12 years as a Neurosurgeon focused on Minimally Invasive and Endoscopic Spine surgery. Like many of us, I became a Neurosurgeon and graduated from a Postgrad University Program and went on to practice with a more traditional approach, with a lack of experience in the more advanced techniques such as Minimal Invasive approaches. Over time I was training and focusing my practice on the Minimal Invasive technique, and with the help of sponsorship from the industry, became a pioneer in many MISS techniques in my country of origin.

I began with Percutaneous Pedicle Fixation and MIS-TLIF, and in a short time was treating Degenerative Deformity with the Transpsoas Approach and Fusion (XLIF). Then in 2011 I met a new and exciting world of spine surgery, with an introduction to Endoscopic Spine Surgery.

This approach was influenced by the Industry and was until 2015 when I was given the opportunity to join AO Spine, and I did not hesitate for a moment. After joining AO Spine a world of opportunities to expand my career became available, from access to limitless information and educational material to educational and Hands-on training, just across the corner and around the world, and today these opportunities are even more available and affordable.

The AO Spine Global Diploma Exam enables candidates to demonstrate that they have attained a level of knowledge expected of a specialist spine surgeon after five years of practical experience.

The Diploma Exam is a formal assessment of the knowledge required for the management of patients with spinal disorders. It is not intended to certify the competence of technical skills or the ability to perform surgical procedures. It is not a compulsory or regulatory certificate of competence or excellence.

Who is eligible for the AO Spine Global Diploma?

In order to be eligible for the AO Spine Global Diploma exam, candidates must be:

- AO Spine members (if you are not an AO Spine member, **join now**)
- Spine surgeons that have been in practice for at least five years.

To receive the Diploma, candidates will need to pass written and oral examinations.

The content of the examinations (written and oral) is based on the AO Spine curriculum.

When the COVID pandemic started back in January 2020, no one anticipated that it would have an impact on every single aspect of our lives. We found ourselves in a stressful situation where we are facing a lot of things for the first time.

The lockdown regulations affected surgeons all over the region. We had to think out of the box. With all the courses, seminars, workshops, and meetings canceled, we had to come up with a way to keep in contact with our members and continue passing knowledge and education. We started the idea of online webinars back in October 2019 before the COVID 19 era. Initially, those webinars were targeting our members in the GCC region. In my opinion, it's several factors that got us there. Choosing attractive topics and influential speakers from all over the world pushed the game to a different level. Another factor which was surprising to me is the number of collaborations that we had with the excellent and very active chairmen of the other AO SPINE MENA chapters. Just when we thought the pandemic could push us apart with all the travel restrictions, it brought us closer with a lot of activities that involved a lot of the region's chapters. No doubt, having a dedicated team of surgeons and project managers who devoted all their efforts for those events to run as smooth and as professional as possible keeping in mind complying with all AO Spine rules and regulations was fundamental. Yet the most important factor, in my opinion, is the power of AO Spine as an international society that surgeons all over the world trust and believe in. It is that novelty of a brand that took generations of excellent spine surgeons and dedicated management to reach the prestigious society that we are all proud of today.

So far, we have conducted ten webinars with more than 1500 attendees from more than 65 countries around the globe. This kind of diversity we previously expected in our major annual events like Global Spine Congress and not from courses or seminars!

Meanwhile, we will also be continuing with the online webinars and hospital-based seminars to have different types of educational activities that can suit our diverse spine community in the region.

Last but not least, we need to realize that we live in a new era, so Think Bigger! What worked before won't work now!



It is important to bring help and assistance as quickly as possible to our recently created section to allow its survival in the AO world. Aware of the delay taken and which must be immediately made up for, it is urgent to take the necessary steps as soon as possible and this should lead to the on-site organization of scientific events under the AO Spine brand.

Indeed, if it is necessary to reach as quickly as possible an appreciable quota of new local members, what better chance we have for educational meetings? At least, we can be satisfied at the beginning by organizing some free webinars. The English-speaking colleagues and brothers from the Middle East are very active and we hope with their collaboration, and given their experience and knowledge in the field, to be able to organize online seminars. We also want to do the same with French-speaking friends, especially those from southern Europe.

Thus, a maximum of spine surgeons from Algeria in particular and from North Africa in general, who have the ability to master the French language will be able to join our prestigious association, thus offering it a new opportunity to expand further.

For example, we could first deal with the following topics: adolescent idiopathic scoliosis, lumbar disc herniation, lesions of the lower cervical spine as well as that of the thoracic and lumbar area. However, since one doesn't have to live by expectations, as an individual, I have allowed myself through the opportunities that were available to me each time, to promote ourselves.

First on Facebook, by advertising about us, in particular on three sites, the CLUB DU RACHIS, OrthoScop (Colloque Orthopédie) and l'orthopédie pédiatrique because our young orthopedists are very present, especially at our annual national congresses. It is in particular the one of orthopaedic surgery held in Oran in November 2019 where I introduced two communications, one entitled, Dynamic osteosynthesis of the cervical spine by the Zephir plate and the other, The degenerative surgical spine, as well as that of rheumatology in Algiers in January 2020 and on the occasion of which, I presented my work on Impact of vertebral tuberculosis on balance of spine: Analysis and surgical perspectives.
